Facebook Group - guidelines

Purpose / role of the Healthwatch Lancashire and Healthwatch Blackpool Voice Box Online Groups:

- Is for members of the public who do not have a mechanism to have their voices heard to have a forum to share their views and experiences of health and social care services through one of two Voice Box Online Groups (dedicated Facebook pages)
 - 1. Healthwatch Lancashire's Voice Box Online
 - 2. Healthwatch Blackpool's Voice Box Online
- Is for Healthwatch to have a link with people who are 'experts by experience' who through living with medical conditions, using health and social care services and/or by living and/or working in their own communities be best placed to inform Healthwatch of their own knowledge, experiences and provide links to others that do not currently have a voice when it comes to health and social care.

Membership:

- Membership of the Voice Box On-line Groups is open exclusively to members of the public who reside in the following areas:
 - Blackpool
 - Fylde & Wyre
 - West Lancashire
 - Burnley, Pendle, Rossendale, Ribble Valley and Hyndburn
 - Preston, Chorley and South Ribble
 - Lancaster and surrounding districts

Guidelines:

- Individuals who are interested in joining on of the Voice Box On-line groups is required to complete the entry questionnaire
- Healthwatch Lancashire and/or Blackpool reserves the right to decline any expression of
 interest which is not deemed suitable or does not meet the entry criteria (see
 membership and purpose/roles of the on-line groups)
- Polls/questions/information will be posted to the group on an ad-hoc basis as and when intelligence and/or discussions are required by Healthwatch Lancashire and/or Healthwatch Blackpool and its members.
- Posts will be managed by the on-line groups Administrator (Communications Team at Healthwatch)
- Post approval may take up to 5 working days
- Healthwatch admin reserve the right to remove any posts/comments that do not comply with the membership ground rules below.





The ground rules for members of our Voice Box Online groups:

- We welcome new members who meet and maintain the ethos of the membership
- We understand that the Voice Box Online group is not a platform for discussing and dealing with individual health and social care complaints (these will be considered outside of the groups on an individual basis by contacting info@healthwatchlancashire.co.uk)
- We respect each other's 'thinking' and value their contributions
- We acknowledge that it's OK to disagree without being disagreeable
- We will not tolerate the use of rude, abusive or offensive language or materials
- We will keep posts 'family friendly' recognising that our membership is made up of people of all ages, backgrounds who have individual beliefs and values
- We will not share personal information with regards to our contact details about ourselves or another member
- We will not use this forum to advertise, fundraise or for self-promotion
- We respect the role of the Voice Box Online Administrator in ensuring that the group upholds the purpose and role of the Voice Box Online Groups.
